
- \*THIS PERMIT PROHIBITS EXCAVATION

- \*CONTRACTOR MUST MAINTAIN ONE TRAVEL LANE IN EACH DIRECTION AT ALL TIMES
- \*CONTRACTOR MUST MAINTAIN A TRAVEL LANE THROUGH ALL INTERSECTIONS BEING CROSSED
- \*CONTRACTOR MUST MAINTAIN ACCESS TO LOCAL MERCHANTS AND RESIDENTS AT ALL TIMES
- \*CONTRACTOR MUST NOTIFY SEPTA OF ANY IMPACT TO THE TRANSIT ROUTE
- MUST MAINTAIN TRAVEL LANES AT ALL TIMES
- MUST MAINTAIN A 6' PEDESTRIAN FOOTWAY AT ALL TIMES
- MUST OPEN STREET TO FULL WIDTH AT THE CONCLUSION OF WORK.
- MUST MAINTAIN GOOD HOUSEKEEPING AT ALL TIMES DURING AND AFTER EVENT/WORK SITE
- MUST PROVIDE & MAINTAIN ACCESS FOR EMERGENCY VEHICLES AT ALL TIMES, I.E. POLICE, FIRE, ETC..
- CONTRACTOR IS RESPONSIBLE FOR POSTING & MAINTAINING "TEMPORARY NO PARKING" SIGNS FOR DURATION OF PROJECT.
- FOOTWAY INTEGRITY MUST BE MAINTAINED AT ALL TIMES, IF ANY DAMAGE OCCURS TO FOOTWAY, CONTRACTOR MUST RESTORE FOOTWAY IN KIND.
- PARKING OF PERSONAL EQUIPMENT PROHIBITED, ANY INFRACTION COULD RESULT IN FINES, TOWING AND RESCISSION OF PERMIT.
- MUST REFER TO PA DOT PUB 213 FOR PROPER WORK ZONE TRAFFIC CONTROL.
