PARTIALLY CLOSE THE WEST FOOTWAY AND ADJACENT CURB LANE ON NORTH 15TH STREET FOR APPROXIMATE 50' ZONE BETWEEN WEST FISHER STREET AND WEST SOMERVILLE STREET

PARTIALLY CLOSE THE NORTH FOOTWAY AND ADJACENT CURB LANE ON PULASKI AVENUE FOR APPROXIMATE 50' ZONE BETWEEN WEST QUEEN LANE AND HANSBERRY STREET\

PARTIALLY CLOSE THE WEST FOOTWAY AND ADJACENT CURB LANE ON WEST DUVAL STREET FOR APPROXIMATE 50' ZONE BETWEEN MCCALLUM STREET AND AMBROSE STREET\
